Handling of Information collected by Automated interview scheduler using OAUTH from Google Users

Talent Now requires two consents from the user using OAUTH:

<u>Send Email</u>: This consent is used exclusively for sending email on behalf of the user. There is no user information requested from Google. There is no user information stored accept access token and refresh token because we do not want to request user's consent every-time, and also re-use the access token till it expires.

<u>Create Events</u>: This consent is used exclusively for creating Google Meet Event. A meeting has to be created on the user (Coordinator's) account because Google does not provide a direct API to create a Google meet event, and the only way to do this is by creating an event on the user's calendar. There is no user information stored accept access token and refresh token.
